# **SUBMISSION GUIDELINES**

The guidelines for the submission of the paper are as follows:

- 1. The papers should be based on the given sub- themes.
- Full paper shall not exceed 3000-5000 words. It shall be typed in Times New Roman, Heading Font size 14, content font Size 12, footnotes font size 10 and 1" margin on all sides with 1.5 line spacing using MS Word.
- 3. Citation shall be strictly in accordance with Bluebook format,20<sup>th</sup> edition.

- 4. The institution may publish selected papers in a peer-reviewed journal under the aegis of the college. Selection of papers for publication shall be the exclusive discretion of the Peer review team and the Editorial Board.
- 5. The paper submissions must be accompanied with a plagiarism certificate and further process of selection will only subject to plagiarism check.
- 6. Co-authorship is permitted up to 2 authors.
- 7. The submission should be done only through the link provided for the same.
- 8. The submissions must not reveal any details with respect to the identity of the authors. The details should only be mentioned in the google form for submission.
- 9. During submission of the paper, the email subject should contain "International conference Final Paper Submission."
