SECOND & THIRD YEAR OF THREE YEAR LAW COURSE

Candidates shortlisted by Directorate of Higher Education, Pune as per the approved list No. Law-3824 / C.R. No. 134 (E-2046505)/CET CELL dated 08.09.2025 should take note that:

- Candidates must be present to report between 10.00 a.m. and 12.00 noon to take token number for verification of documents in College Office personally.
- As soon as token number is collected, students will have to arrange and produce original documents as per list for verification and submission. Admission will be confirmed only on production of all required documents.
- After verification of documents, candidates shall have to fill the online College Admission Form. (Link will be provided by the college after the verification of documents.)
- The candidates who fulfill the above conditions will be allowed to pay fees online through UPI / QR / Net Banking.
- Payment receipt will be issued after the completion of admission.



List of Required Documents (to be carried in original with two self-attested photocopies in the following order):

1. All Semester Marksheets (Law).
2. Photocopy of No Objection Certificate from the previous College
3. Eligibility Certificate issued by University of Mumbai (for students from other Universities).

5. Transfer / Migration Certificate of Previous College / University.

In case the same is not available at the time of admission, a period of 15 days will be granted for submission, for which the candidate shall submit a separate Undertaking.

6. ARA approved list for Confirmation of admission of the First Year from previous College.
7. Anti-Ragging Affidavit – To be submitted by both the student and parent/guardian. (Softcopy & Hardcopy)

2. Go to www.antiragging.in

5. Fill the Form and Submit
