All the candidates aspiring to take admission in the College in **First Year of Three-Year Law Course Institutional Level Round Merit List** should take note that:

1. Candidates must be present to report between 10.00 a.m. and 12.00 noon to take a token number for verification of documents in the College Office personally.
2. After collecting the token number, students will have to arrange and produce original documents as per the list for verification and submission. Admission will be confirmed only on production of all required documents.
3. Students have to fill the Pre-online Registration Form of University of Mumbai on: mum.digitaluniversity.ac
4. Anti-Ragging Affidavit – To be submitted by both the student and parent/guardian. Generate online at: https://www.antiragging.in/affidavit_affiliated_form.php
5. APPR ID / ABC ID – To be submitted by all students. This can be generated online. <https://abc.gov.in>
6. After verification of documents, candidates shall have to fill the online College Admission Form (link will be provided by the college after verification).

7. Candidates who fulfil all the above requirements will be allowed to pay fees online through UPI / QR Code / Net Banking.
8. Payment receipt will be issued after the completion of all admission formalities.
9. The candidates are required to carry all original certificates/documents with two attested photocopies for admission.
10. In case the candidates are awarded Grades/CGPA instead of marks, the conversion of Grade/CGPA to percentage of marks would be based on the formula/procedure certified by the Board/University/Institution who has awarded the same. It is obligatory on the part of the candidate to bring the conversion certificate from the Board/University/Institution.
11. Candidates are informed to bring the documents as per the information brochure published by State CET Cell.
